






National ADS-B Program Update



 Lake Charles Terminal Approach Control – ADS-B Initial Operating Capability June 2018


ADS-B Avionics Equipage Rule – Jan 2020








Significant Events Since Last HSAC in May 2018 (cont'd)

- Operator feedback on Sabine Pass (SA) 13B AWOS
 - FAA requested operator feedback on the need to retain the SA 13B AWOS—non-response was treated as concurrence with the FAA proposal to decommission and relocate
 - Four (4) helicopter operators responded (Bristow, Era Helicopters, PHI, Westwind)...recommended retaining the AWOS
- FAA proposal withdrawn—will maintain AWOS until SA 13B P&A



AIC Decisions / Feedback

- AIC feedback on Mustang Island A85A platform AWOS
 - AIC concurred with relocating ADS-B in May 2018
 - ADS-B to be decommissioned Dec 2018
- FAA proposal: decommission and relocate AWOS when the ADS-B is removed in 2019



AIC Decisions / Feedback

AIC feedback on AWOS unreliable winds

- How important is AWOS wind reliability? Platform obstructions significantly impact reliability of sensor information
- Relocating a wind sensor would require platform owner help and FAA investments


